WHAT:

She will share examples from the many cases she has handled of fair housing issues that arise with all types of employees. The newer issues in fair housing will also be explored including sexual harassment, domestic violence, illegal harassment, second hand smoke, marijuana, and the challenges of processing reasonable accommodation requests and managing properties with families with children.
