In this session we will review changes to rules for scheduling inspections, including the new 14 day notice, consequences or failure, new requirements for appeal, and goals & affirmations of the upcoming reforms.

# PART 2: QUALITY IN COMPLIANCE..... NEW STANDARDS ON REAC INSPECTIONS

A review of the existing basic design of a UPCS/REAC Inspection, and then introduce the new concepts and goals which will be gradually implemented over transition to HUD NSPIRE. The new changes will take the "form and function" requirements in place now and transition to "safety and quality". This means new standards for livability, quality repairs, and metrics which measure proper everyday compliance. We will review what this means and how to best prepare for the new realities to come.
