HVAC TRAINING PLUS OPTIONAL EPA 608 CERTIFICATION

Federal Regulations – Section 608 of the Clean Air Act requires all persons who maintain, service, repair, or dispose of appliances containing regulated refrigerants, be certified in proper refrigerant handling techniques as required by the National Recycling and Emission Reduction Program. Regulated refrigerants currently include CFC, HCFC, HFC, and HFO refrigerants. This course is designed to provide associates with the knowledge necessary to pass the Federal EPA 608 Exam. It has several sections which include Core, Type I, Type II, Type III, and a universal certification. Associates can pass any, or all the sections. If a passing score is achieved in all 4 sections, you will receive a Universal Certification.

Who should attend: Managers, Supervisors, Technicians, Aspiring Technicians, or anyone that wants to learn more about working with refrigerants or working on A/C Systems. It is a must for those that wish to get certified.

Technicians who already possess a certificate are required to learn about all the updates and changes in the industry which include new refrigerants, new equipment, requirements, changes in fines and violations, charging, compatibilities, and best practices. Mark has been teaching these methods, with simple to understand delivery of technical information, that gives his class one of the highest success rates. He will address common mistakes, myths, and make sure you have all the accurate information.
